

## Privacy notice

1. <u>Awareness</u> – Church Leaders and key people at HCF are aware that the law has changed to the GDPR. They appreciate the impact of this legislation on the data kept and the way the data is stored regarding individual members and those known to the church family. HCF has identified areas where there is a need for vigilance in order to comply with the law under the GDPR.

2. <u>Information held</u> - Personal data is provided by the individual and not by a third party. No one may pass on details to a third party - this must be given by the individual unless written permission is provided.

Registers include – Members and friends Name, address, birthday, landline, mobile and email address Parent / Guardian & child attending Toddler Group, Name /phone only Parent / Guardian & child attending Epic Explorers Name /phone / address Individuals contacted through Community Chaplains Name /phone / address Visitors to the church meetings Usually only Name / phone provided Register of Membership, dedication, conversion and baptism. Name and date Data relating to applications for roles within the church. Ex-Offenders Contracts

This information is **not shared with anyone** without the consent of the individual. Data will not be passed to another party, rather, should an individual outside of the church family wish to contact someone, their contact details will be taken and the individual will be asked to contact them.

These registers are maintained annually but are amended as soon as a request is received to add/remove a name/data.

All data is stored in a secure place in the church office.

Church leaders have access to all data.

A copy of the data of **Members and Friends** is kept by Laura Balbuena and Pauline James for the purpose of sending greetings cards, and information of forthcoming events.

The **church register** is held by all members and contains the data relating to **Members and Friends** who have agreed to allow their data to be shared within the church family.

All members have a '**Prayer Chain'** sheet with names /'phone numbers of individuals who have agreed to participate in this support group.

Community Chaplains have access to data received from **members of the community** who have been contacted through the scheme and who have agreed to give their details to the chaplain.

Individuals must **positively opt-in**, in order for the information to be stored. Copies of their opt-in paper are stored in the safe in the church office. See **Consent Form**.

3. <u>Communicating Privacy Information</u> – When collecting personal data, people will be told who will have access to the information and how this information will be used, see **Consent Form**. Under the GDPR people will be told the lawful basis for processing the data, data retention periods and the individual's right to complain to the ICO if they think there is a problem with the way their data is handled. The GDPR requires this information to be provided in concise, easy to understand /clear language, see **Consent Form**.

Any information shared confidentially by an individual, will not be shared with anyone else without the permission of the person disclosing the information unless the information is of an illegal nature or a safeguarding matter. In such cases, the individual will be encouraged to pass on the information themselves but failure to do so will necessitate a church leader informing the necessary authorities.

4. <u>Individual's Rights</u> - We ensure that all procedures cover all the rights of individuals, including how personal data is deleted from the records or how data is provided electronically. The GDPR includes the following rights for individuals: the right to be informed; the right of access; the right to rectification; the right to erasure; the right to restrict processing; the right to data portability; the right to object; and the right not to be subject to automated decision-making including profiling.

The individual is the only person who will make the decision to delete their information from the data kept. There is no portability of data at HCF.

5. <u>Lawful basis for your processing data</u> – Within the GDOR, HCF has the lawful basis for processing data, with the responsibility to communicate this with all whose data is held.

6. <u>Data breaches</u> – in the unlikely event of any data breaches the ICO will be informed and each individual affected will be notified.

We will include your details in the 'Church Directory' which is circulated to Church members and friends.


#### Birthdays and news for particular prayer needs (prayer chain)
